WHEREAS. TENNESSEE CODE ANNOTATED 67-5-2404 (2)(A)

PROVIDES THAT THE TRUSTEE SHALL DELIVER THE DELINQUENT LIST SHOWING ALL UNPAID LAND TAXES TO AN ATTORNEY CHOSEN BY HIM WITH THE APPROVAL OF THE COUNTY EXECUTIVE/COUNTY MAYOR, AND

WHEREAS. TENNESSEE CODE ANNOTATED 67-5-2404 (2)(A)

PROVIDES FOR COMPENSATION OF THE ATTORNEY TO BE DETERMINED UPON NEGOTIATIONS THROUGH THE TRUSTEE AND ATTORNEY, SUBJECT TO APPROVAL OF THE COUNTY LEGISLATIVE BODY AND THAT SAID FEE SHALL NOT EXCEED TEN PERCENT (10%) OF ALL DELINQUENT LAND TAXES COLLECTED.

THEREFORE, BE IT RESOLVED BY THE MONROE COUNTY LEGISLATIVE BODY THIS DAY IN REGULAR SESSION THAT CHARLES RIDENOUR BE CHOSEN AS ATTORNEY TO COLLECT DELINQUENT TAXES FOR MONROE COUNTY, TENNESSEE, AND BE FURTHER RESOLVED THAT HIS FEE SHALL BE TEN PERCENT (10%) OF ALL DELINQUENT LAND TAXES COLLECTED, ALL IN ACCORDANCE WITH TENNESSEE CODE ANNOTATED 67-5-2404 (2) (A).

226-8 JUSTICE COMMITTEE REPORT BY MAYOR YATES

The Justice Committee met Feb 12, 2013 @ 6:00 PM in the JPK Board Room. At that meeting the committee reviewed three (3) properties for possible jail sites. They are Sloan, Atkins and Martin. During the meeting I introduced Grant Tharp with Cope and Associates, to give the committee a cost analysis for utilities and site preparation for each property. The committee asked Mr. Tharp his professional opinion of which tract would be the best suited for a jail site. Mr. Tharp recommended the Atkins property, due to the site, utilities and future expansion.

The committee was in agreement with Mr. Tharp's recommendation. The committee chose to recommend to the County Commission to allow Monroe County Mayor to enter into negotiations with the Atkins family, the price of the land, with the option to buy pending soil testing and other requirements.

Due to the fact that the Justice Committee will be having required training and meeting with State of Tennessee TCI - Mr. Bob Bass and Mr. Jim Hart of CTAS on March 21, 2013, I would like to request the County Commission to postpone the request from the Justice Committee until the March meeting which will be March 26, 2013.
